1. HOW TO ENTER. No cost to enter. No purchase necessary to enter. A purchase does not improve your chances of winning. Kirtland CU's I Love My CU Cooler Sweepstake begins July 26, 2024, and ends August 8, 2024 (the "Promotion Period"). There is one way to enter:

You will be entered into the drawing if you: follow ANY ONE OF our social channels, create a post, and tag Kirtland CU in that post. You must also use the hashtag #ilovemycreditunion. Our social channels are Facebook, Instagram, and LinkedIn.

One Entry Per Person.

- **2. ELIGIBILITY.** The drawing is open to individuals 18 years of age or older who qualify under these rules. Staff, Volunteers, and their families are not eligible for this drawing.
- **3. PRIZES.** Contest winners will receive one of seven Kirtland-branded coolers. One of seven Kirtland-branded coolers, valued at \$100 each. The prize is provided by Kirtland Credit Union. Winners will not receive cash no substitutions or transfers by winners are permitted. The odds of winning are dependent on the number of eligible entries received.
