

OFFICIAL CONTEST AND SWFFPSTAKE RULES

MONEY EDU REGISTRATION SWEEPSTAKE

- **1. HOW TO ENTER.** NO PURCHASE NECESSARY TO ENTER. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. Kirtland CU's MoneyEdu Registration Sweepstake begins August 8, 2023, and ends September 29, 2023 (the "Promotion Period"). There are two ways to enter:
 - 1. You will be entered into the drawing if you: register for a new MoneyEdu account by visiting https://www.moneyedu.org/public/welcome.cfm?code=KFCU.
 - 2. Alternatively, hand print your complete name, address, age, daytime/evening phone numbers, email address, and send it to MoneyEdu Sweepstake Entry, Marketing Kirtland CU, PO Box 80570, Albuquerque, NM 87198. Entries must be handwritten and legible. Illegible entries will be void. Must be postmarked by September 20, 2023, and received by September 28, 2023.

One Entry Per Person.

- **2. ELIGIBILITY.** The drawing is open to individuals 18 years of age or older who qualify under these rules. Staff, Volunteers, and their families are not eligible for this drawing.
- **3. PRIZES.** Contest winners will receive one of eight Kirtland-branded Yeti tumblers. The prize is provided by Kirtland Credit Union. Winners will not receive cash no substitutions by winners are permitted. The odds of winning are dependent on the number of eligible entries received. No substitution or transfer of prizes is permitted. The winners are responsible for all applicable federal, state, and local taxes. If an individual winner lives greater than 50 miles from a Kirtland CU branch, we will ship the prize to the said winner.

Winners will be notified by mail, email, or telephone within 30 days.
